C. Report out on Closed Session

Ralph Nevis reported that the Board met in Closed Session with legal counsel regarding the one item listed on the Closed Session Agenda and took no reportable action.

D. Monthly/YTD revenue and expenses

Greg Fabun reported on the monthly revenue and expenses for April 2023. Fund 870's starting balance was approximately \$6.2M. There was \$2.5M in revenue and expenditures were \$412.4k. The ending balance was \$8.22M. Fund 871's starting balance was approximately \$5.1M. The Agency received \$5.2M in revenue. Expenditures totaled \$788k. The ending balance for fund 871 was approximately \$9.5M. The Agency's combined cash position for the month was \$35.3M and includes the state advance (fund 257) for the federal project of \$17.6M.

A. WSAFCA Project Updates

Greg Fabun reported on WSAFCA project updates highlighting the following:

As of 8/10/23, the Agency's combined cash position was approximately \$33.2M due to the 5% cash payment to the Corps; preparation of the Southport LERRDs credit package; Southport restoration area maintenance; additional 5% cash request from the Corps for ~\$3M for balance of FY23; YBEL-South construction; YBEL-North low bid ~\$9M; Sacramento River North Levee design; Stone Lock design, and federal appropriations.
